

Warranty Information - Lafayette and LouverDrape

This warranty is being given to you by LouverDrape, a division of Levolor Home Fashions ("LouverDrape") and Lafayette Venetian Blind, Inc. All Lafayette and LouverDrape Products, except for EverClear Louver-Groover Vanes ("EverClear Vanes") used on LouverDrape Products, are warranted against defects in materials and workmanship. EverClear Vanes and Clear Edge Vanes used on Lafayette and LouverDrape Products are warranted only not to yellow or discolor from natural causes. Louver materials up to 120" in length are warranted. If louver length exceeds 120", twisting may occur. This warranty extends only to you as the original buyer at retail. This warranty does not cover normal wear and tear or any damage or loss caused by abuse, misuse, or improper installation. All fabrics can lose original intensity after long exposure to the sun. When left for extended periods in direct sunlight, plastics tend to yellow or crack. All cords will eventually wear out. Lafayette and LouverDrape consider these things normal wear and tear not covered by this Warranty. Fabric colors vary from lot to lot and may not exactly match sample swatch or previous purchases. This Warranty coverage will be for as long as you, as the original buyer at retail, own the Lafayette or LouverDrape vertical track. Louver materials have 3 year limited warranty against defects in materials and workmanship. The limited warranty covers DigiDrive motorized components and circuits for a 2 year period. ANY IMPLIED WARRANTIES WHICH YOU MAY HAVE ARE LIMITED IN DURATION TO THE TIME DURING WHICH YOU, AS THE ORIGINAL BUYER AT RETAIL, OWN THE LAFAYETTE OR LOUVERDRAPE PRODUCT. Some states do not allow limitations on how long an implied Warranty lasts, so the above limitation may not apply to you. If your Lafayette or LouverDrapeProduct is defective during the warranty period or if your EverClear Vanes yellow or discolor during the warranty period, we will, at our option, either repair or replace, without charge, that defective product. This will be your sole remedy under this Warranty. Repair or replacement of defective products are your sole remedy under this Warranty and in no event shall we be liable for transportation costs to or from the dealer, costs of removal, costs of reinstallation of the vertical blind, or incidental or consequential damages. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. To obtain service under this Warranty, return the Lafayette or LouverDrape along with the original sales receipt to the dealer from which it was purchased. This Warranty gives you specific legal rights, and you may also have other rights which may vary from state to state. Effective Date: July 2005.
